Making real and lasting change requires the contributions, expertise, and commitment of everyone in our community – including our Board of Directors. We know that the social issues facing our community are challenging. We also know that the ways that people want to connect to make a difference in their community are changing. Working on our Board of Directors, you will help us adapt to meet these needs as we elevate our role as a catalyst for change in Perth and Huron Counties.

- **Connected community supports that are focused on belonging and inclusion**, because we know that isolation, mental health, and informal and formal supports are critical issues coming out of the pandemic;
- **Dedicated investment for equity-seeking and vulnerable groups**, because we know that real, tangible barriers to resources and belonging in our communities persist;
- **Aligned collaborative supports for food, housing, and financial security**, because we know individuals and families need comprehensive opportunities to stabilize, recover, and build their futures; and,
- **Increased resilience in children and youth through emotional wellbeing**, because we know that helping to prevent and mitigate adverse childhood experiences is both urgent and foundational to lifelong potential.

How You Can Help Us

We are committed to ensuring representation on our Board of Directors that is consistent with the communities we serve. Based on the current Board composition in terms of skills, expertise, demographics and lived experience, we welcome a wider range of perspectives to ensure a more diverse set of voices at our table. Although applications are accepted from all interested individuals, we particularly welcome applications from individuals who bring any of the following perspectives to their work:

- People living and/or working in Huron County
- Individuals between 18 – 35 years of age
- Black or racialized individuals
- Indigenous peoples
- Individuals who identify as 2SLGBTQI+
- Individuals who have experienced homelessness or being under housed

Individuals without board experience are welcome to apply. Training and mentorship are provided.

Board of Directors Position

Responsibilities

The Board of Directors has a governance mandate and is responsible for ensuring United Way's mission and strategic plan are achieved. The board is committed to fostering an equitable and inclusive atmosphere in which every board member's perspective is welcomed, respected and valued.

Board members are responsible for:

- Providing strategic leadership to United Way, including but not limited to:
 - establishing the long-term direction and vision;
 - monitoring and evaluating the implementation of the strategic plan;
 - ensuring action is taken on our commitment to build a more equitable future and a community where everyone can thrive;
 - identifying and helping mitigate organizational risks;
 - overseeing the financial health of the organization; and,
 - providing business and personal insights to inform major organizational decisions.
- Acting as a positive and passionate ambassador for United Way both in meetings and out in the community.
- Keeping informed about the organization, its issues, and its connection to the community through active participation.
- Supporting activities within the annual fundraising strategy, as appropriate.
- Applying equity, diversity, and inclusion lens to their work.

Time Commitment

Board members are elected for a three-year term and can serve two consecutive terms. During that term, board members are expected to:

- Attend regular board meetings. Meetings take place on the second Tuesday of the month from 5:30pm-7:30pm in the months of October, December, March, May, and June. Meetings alternate between in-person (with a virtual option) or only virtual. In-person meetings will alternate between our head office at United Centre (32 Erie St, Stratford) and other venues in the region.
- Attend an all-day in-person Board retreat on a Saturday in September.
- Attend the Annual General Meeting on the first Wednesday in July at 5:30 pm. The AGM will be in-person with a virtual option.
- Participate on one United Way committee (Audit & Finance, Governance & Development, Community Impact & Allocations, Social Research & Planning Council, United Housing Ad Hoc Committee). Between Board meetings, members are asked to actively work on their committee projects to ensure activities proceed according to schedules.
- Attend United Way special events and fundraisers and represent United Way at community events, when available.

Total time commitment of approximately 4-6 hours a month plus meeting preparation time.

Training Provided

- 2-hour Board member orientation will be provided
- Ongoing education and team building throughout Board membership
